The Elections Committee recommends the following General Elections calendar.

A TALB office candidate may give a speech, limited to two (2) minutes at the February 27<sup>th</sup> Representative Council meeting.

A CTA State Council candidate may give a speech, limited to one (1) minute at the February 27<sup>th</sup> Representative Council Meeting.

## Elections are based on a majority vote.

Majority - "More than half."

Majority Vote - More than half of the votes cast by person legally entitled to vote, excluding blank or illegal ballots. For example:

- If 19 votes are cast, a majority (more than 9 1/2) is 10.
- If 20 votes are cast, a majority (more than 10) is 11.
- If 21 votes are cast, a majority (more than 10 1/2) is 11.
