**The Elections Committee recommends the following General Elections calendar.**

**A TALB office candidate may give a speech, limited to two (2) minutes at the February 25<sup>th</sup> Representative Council meeting.**

**A CTA State Council candidate may give a speech, limited to one (1) minute at the February 25<sup>th</sup> Representative Council Meeting.**

*Elections are based on a majority vote.*

**Majority** – “More than half.”

**Majority Vote** – More than half of the votes cast by person legally entitled to vote, excluding blank or illegal ballots. For example:

• If 19 votes are cast, a majority (more than 9 ½) is 10.

• If 20 votes are cast, a majority (more than 10) is 11.

• If 21 votes are cast, a majority (more than 10 ½) is 11.
